exempted from taking State Eligibility Test in Computer Appreciation and Applications (SETC).


- a. M.Tech/B.Tech (Computers), MCA/BCA or Diploma in Computers from recognized Institutions e.g. Polytechnics.
- b. Basic Computer Literacy Certificate from any recognized centres established under the National Institute of Electronics and Information Technology (NIELIT) (erstwhile DOEACC Society)
- c. Haryana State Certificate in Information Technology (HS-CIT) from the authorized learning centers (ALCs) of the HKCL.


