Further, as per the Endst. Amendment/27/5/13/C-1/11524 dated 09.08.2019 of the Haryana State Cooperative Apex Bank's Staff Service (Common Cadre) Rules, 1988, the above promotes shall have also to qualify the State Eligibility Test in Computer Appreciations (SETC) conducted by the hartron or any other Agency as approved by the Govt. within a period of probation of one year, extendable by one year, failing which they will be reverted back. The employees possessing any of the following qualifications are

exempted from taking State Eligibility Test in Computer Appreciation and Applications (SETC).


- a. M.Tech/B.Tech (Computers), MCA/BCA or Diploma in Computers from recognized Institutions e.g. Polytechnics.
- b. Basic Computer Literacy Certificate from any recognized centres established under the National Institute of Electronics and Information Technology (NIELIT) (erstwhile DOEACC Society)
- c. Haryana State Certificate in Information Technology (HS-CIT) from the authorized learning centers (ALCs) of the HKCL.

The above promotee officials shall submit their joining at their respective place of posting and forward the same to the Head Office through their Section In-Charges.
