



Pursuant to the Resolution No. 5 passed by the Board of Directors in its meeting dated 04.10.2022, Sh. Rakesh Chander, Steno-typist is hereby promoted to the post of Stenographer as per the Final Seniority List of Clerks/Setno-typist issued vide No. Estt./EA-I/2022-23/3351 dt. 11.08.2022 in the Pay matrix FPL-6 (Rs. 35,400-1, 12,400) with immediate effect.

Further, as per the Endst. Amendment/27/5/13/C-1/11524 dt. 09.08.2019 of the Haryana State Cooperative Apex Bank's Staff Service (Common Cade) Rules, 1988, the promotee to the post of Stenographer has also to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) conducted by the HARTRON or any other authorized agency as approved by the Government within the probation period of one year, extendable by one year, failing which he will be reverted back. The employee possessing any of the following qualifications is exempted from taking State Eligibility Test in Computer Appreciation and Applications (SETC):-

- a) M.Tech/B.tech (Computers), MCA, BCA or Diploma in Computers from recognized institutions e.g. Polytechnics.
- b) Basic Computer Literacy Certificate from any recognized centre established under the National Institute of Electronics and Information Technology (NIELIT) (erstwhile DOEACC Society).
- c) Haryana State Certificate in Information Technology (HS-CIT) from the authorized learning centers (ALCs) of the HKCL.

The names of Smt. Padma, Steno-Typist at Sr. no.1 and Smt. Ajit Kaur, Clerk at Sr. no. 2, were not proposed for promotion as they were not having requisite qualification for promotion. Further, the inter-se seniority of promotee shall remain the same as stood in the final seniority List of Clerks/Setno-typists issued on 11.08.2022.


